	Prohibition Against DEI Practices: Senate Bill 12 The governing body of a charter school must adopt a policy in accordance with TEC § 11.005, addressing discipline of an employee or contractor who engages in or assigns to another person DEI practices or duties. A physical and electronic copy of the policy must be provided to each school employee contractor.
	Parental Engagement Policy: Senate Bill 12-The governing body of a charter school must develop a policy that satisfies the requirements of TEC § 26.0071, in furtherance of increased parental access and engagement in their child's education
